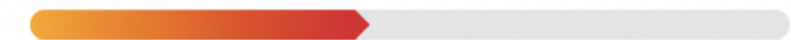

**CERN Council declares its intention to terminate cooperation agreements with Russia and Belarus at their expiration dates in 2024.**

Geneva, 17 June 2022. At its 208<sup>th</sup> meeting yesterday, the CERN Council reiterated its denunciation of the continuing illegal military invasion of Ukraine by the Russian Federation with the involvement of the Republic of Belarus, which has resulted in a widespread humanitarian crisis and significant loss of life. CERN was established in the aftermath of World War II to bring nations and people together for the peaceful pursuit of science. Member States recalled that the core values of the Organization have always been based upon scientific collaboration across borders as a driver for peace, and stressed that the aggression of one country against another runs counter to these values.

The Council declared that it intends to terminate CERN's International Cooperation Agreements (ICAs) with the Russian Federation and the Republic of Belarus at their expiration dates in 2024. However, the situation will continue to be monitored carefully and the Council stands ready to take any further decision in the light of developments in Ukraine.

CERN's International Cooperation Agreements, ICAs, normally run for five years, and are tacitly renewed for the same period unless a written notice of termination is provided by one party to the other at least six months prior to the renewal date. The ICA with the Russian Federation expires in December 2024, that with the Republic of Belarus in June 2024.

These measures follow those already adopted at an extraordinary meeting of the Council on 8 March, and at the Council's regular meeting on 25 March. The Council reaffirmed that all decisions taken to date, along with the actions undertaken by the Management, which have had a marked impact on the involvement of the Russian Federation and the Republic of Belarus in the scientific programme of the Organization, remain in force.

The Council also decided to review CERN's future cooperation with the Joint Institute for Nuclear Research (JINR) well in advance of the expiration of the current ICA in January 2025.

### **Authorship**

Authorship is the most important element in the academic records. It acknowledges every author's contribution to the scientific result and establishes their academic responsibility for it. Excluding some authors for non-scientific reasons damages the scientific credibility of the work.

### **Constraints**

Belle II members in some countries cannot at this time be listed as authors on papers together with Russian institutes or funding agencies. In particular, this is the case for scientists from Ukraine. Ensuring the unity of the Belle II Collaboration necessitates respecting this constraint.

### **Summary – Belle II Measures**

Considering the above points, the Belle II Collaboration adopts the following measures:

- Belle II members from Russian institutes continue to contribute to the experiment as collaboration members.

As for publications,

- We list the names of all individuals who signed the authorship confirmation.
- Affiliations, country names, and funding-agency acknowledgements are not listed.

These measures will be reviewed regularly at every Belle II General Meeting until these extraordinary measures are no longer required.

## Capable of Peace in Times of War / **peace report**

The Russian war of aggression in Ukraine has caused the European security architecture to collapse. The Peace Report 2022 analyzes the escalation, highlights consequences for Ukraine and the region, and focuses on the reorientation of German and European security and defense policy. In addition to the global implications of the war, the report also outlines the conditions for success and limits of sanctions and analyzes the crisis of the global nuclear order. Furthermore, the research on global conflict shows that internationalized conflicts, jihadist violent actors, and violence and discrimination against women and LGBTQI\* minorities require new peace policy emphases. And the steadily expanding competencies of security institutions within democracies due to the threat of terrorism, pandemics and extremism also require stronger democratic control.
